Resolution No. 2015- 052

RESOLUTION PROVIDING FOR THE LGU COUNTERPART IN ALL BUB PROJECTS FUNDED BY THE DEPARTMENT OF TRADE AND INDUSTRY, IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, in a letter dated April 14, 2015, Atty. Suzette T. Alquisada, *Municipal Mayor* requested the Sangguniang Bayan thru Hon. Roel T. Jarina, Vice Mayor & Presiding Officer, for the URGENT passage of a *Sangguniang Bayan Resolution Providing for the LGU Counterpart in All BUB Projects Funded by the Department of Trade and Industry*;

WHEREAS, the Department of Trade and Industry (DTI) 6, through the DTI-Iloilo Provincial Office is a participating agency in the implementation of the Bottom-Up Budgeting (BUB) Projects in FY 2015;

WHEREAS, LGU-Tigbauan is one of the identified focus LGUs and has the following approved projects amounting to: **Three Million One Hundred Thousand Pesos (P 3,100,000.00)** which were included in DTI's budget for FY 2015:

1. Rural Micro-Enterprise Development Program (70 M.V./Small Enterprise Trained and Given Financial Support) - P1,000,000.00
2. Livelihood Yamang Pinoy (conduct training, product development and marketing)- P1,500,000.00
3. OTOP Store Express/Pasalubong Center - P600,000.00;

WHEREAS, anent to the implementation of BUB Projects, the DBM-DILG-DSWD-NAPC Joint Memorandum Circular (JMC) No. 6, Series of 2015 dated 27 February 2015, item 4.6 require the 'Provision of LGU counterpart funding as follows:

"4.6. Provision of LGU counterpart funding

4.6.1. *Municipalities must provide a cash counterpart for the BUB program equal to a percentage of their FY2014 Local Development Fund (LDF). This must be sourced from LGU funds, but not necessarily from the LDF.*

4.6.2. The percentage shall be based on the proportion of the BUB and NCDDP funding to 20% of the LGU Internal Revenue Allotment, or the LDF, as follows: Ratio of approved BUB budget to the FY2014 LDF Required Cash Counterpart for Municipalities Up to 100% of the LDF 10% of the LDF amount Over 100% up to 150% of the LDF 15% of the LDF amount Over 150% of the LDF 20% of the LDF amount

4.6.4. Counterpart funds required need not be allocated on a per project basis. Identified counterpart funds may be used to fund projects that are 100% funded by the local government unit, as long as the project has been identified through the LPRAT or Enhanced LDC participatory planning process.”

WHEREAS, the LGU-Tigbauan has provided counterpart fund for BUB projects in its 2015 Executive Budget in the amount of P 1,810,000.00, a portion of which shall be utilized for the above mentioned projects funded by the DTI as required by JMC No. 6;

WHEREAS, LGU-Tigbauan is eligible to implement the BUB project as evaluated by DTI on the basis of the eligibility standards set forth in JMC No. 6;

NOW, THEREFORE, on motion of HON. RENEE LIBRODO-VALENCIA, Chairperson, Committee on Appropriations and duly seconded by Hon. Virgilio Teruel, Hon. Marlon Teruñez, Hon. Ma. Gerrylin Santuyo-Camposagrado, and Hon. Ariel Bernardo,

RESOLVED, to provide for the LGU Counterpart in All BUB Projects Funded by the Department of Trade And Industry, In The Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to furnish copies of this Resolution to DTI-Iloilo Provincial Office, to Mayor Suzette Tenefrancia-Alquisada, this municipality and to all concerned for their information and/or appropriate action.
