WHEREAS, the Subdivision Application of MARK OLIVER G. TUPINO & AILEEN C. TUPINO ET-AL With TCT No. F-44266 Lot No. 858 with an Area of 1,465 Square Meters More Or Less, containing two (2) lots Located at Brgy. - This approval does not exempt the proponent from pertinent requirements of other government agencies;
- This approval does not exempt the proponent from securing registration and license to sell from HLURB.
