WHEREAS, the late Hon. Celso Tupan Ledesma is indeed an exemplar of honest, dedicated and sincere public service he unselfishly shared to his hometown and “kasimanwas” for more or less 40 years of his life;

WHEREAS, during his tenure as public servant, Hon. Celso Tupan Ledesma has been instrumental for various development efforts that contributed to what Tigbauan has become today as a town filled with promises of progress and a better tomorrow;

WHEREAS, the late Mayor is most admired for his humility and unassuming personality being always concerned about the greatest good for the greatest number and he has exhibited a special concern and love for the poor and those who have less in life;

WHEREAS, Hon. Celso Tupan Ledesma’s brand of public service will forever be etched in the hearts and minds of his kasimanwas as a source of inspiration for those who aspire to render selfless service to Tigbauan; a kind of service that is concerned with what can be offered, what can be done and what can we give rather than what we can get or receive and what we cannot do;

WHEREAS, his legacies as a faithful and loving son of Tigbauan are noteworthy and must be shared to the younger generation who shall inherit this place and who are expected to love Tigbauan as much as their predecessors like former Mayor Celso Tupan Ledesma;
