RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOILO DOCTOR'S COLLEGE OF MEDICINE, INC. FOR THEIR PREVENTIVE AND COMMUNITY MEDICINE (PCM) EXPOSURE.

WHEREAS, Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor, in a letter dated May 4, 2015 to the Sangguniang Bayan (thru Hon. Roel T. Jarina, Vice Mayor) requested for the URGENT passing of a "Resolution Authorizing The Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement (MOA) With The Iloilo Doctor's College Of Medicine, Inc. For Their Preventive and Community Medicine (PCM) Exposure";

WHEREAS, the Iloilo Doctors' College of Medicine, Inc. has continuously implemented the Iloilo Doctors' College of Medicine Student Community Exposure Program under the Department of Family & Community Medicine in the Municipality of Tigbauan, Province of Iloilo;

WHEREAS, the said Student Community Exposure Program is considered an effective strategy in community development with focus on "health", where the Local Government Unit of Tigbauan and Iloilo Doctors' College of Medicine, Inc. and the people of Tigbauan, Province of Iloilo becomes active partners in health development;

WHEREAS, the said program implemented by both parties shall be composed of various components and shall include community organization; delivery of health services, training and education, student exposure; early child care and youth development;
