RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-04-15-301 OF TERESITA T. GARVILLES WITH TCT NO. T-9455 LOT NO. 927-A-2 WITH AN AREA OF 8,888 SQUARE METERS MORE OR LESS, CONTAINING TWENTY FOUR (24) LOTS LOCATED AT BRGY. NAMOCON, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application of Teresita T. Garvilles With TCT No. T-9455 Lot No. 927-A-2 with an Area of 8,888 Square Meters More Or Less, containing Twenty Four (24) lots Located at Brgy. Namocon, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on April 28, 2015 for authorization and approval;

WHEREAS, the purpose/intend of this application is to sell;

WHEREAS, the said land parcel was classified as built-up area in the zoning classification;

- c.) *Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;*
- d.) *This approval does not exempt the proponent from pertinent requirements of other government agencies;*
- e.) *This approval does not exempt the proponent from securing registration and license to sell from HLURB.*
