RESOLUTION CONFORMING AND ADOPTING MDC RESOLUTION NO. 2015-001 ENTITLED "RESOLUTION APPROVING THE RE-PROGRAMMING OF THE AMOUNT OF FIVE MILLION SIX HUNDRED NINETY THREE THOUSAND ONE HUNDRED SIXTY FOUR PESOS AND SIXTY EIGHT CENTAVOS (P 5,693,164.68) FOR THE CONTINUING CONSTRUCTION OF PHASE III TIGBAUAN PUBLIC MARKET AND HEALTH AND SANITATION PROGRAMS FROM VARIOUS BALANCES IN THE 20% CONTINUING APPROPRIATIONS REPRESENTING UNIMPLEMENTED DEVELOPMENT PROJECTS FOR THE YEARS 2014, 2013 AND PRIOR YEARS AS OF MAY 8, 2015"

WHEREAS, the Municipal Development Council (MDC) in its 12 May 2015 meeting at the Conference Room, Tigbauan Municipal Hall passed Resolution No. 2015-001, approving the re-programming of various balances of the 20% Continuing Appropriations for the years 2014, 2013 and prior years as of May 08, 2015;

WHEREAS, the balances of the 20% Continuing Appropriations reprogrammed under the aforementioned MDC Resolution No. 2015-001 remained unutilized for several years and are balances from unimplemented development projects as certified by the OIC Municipal Accountant, the Municipal Budget Officer and the OIC Municipal Treasurer;

WHEREAS, the construction of Phase III Municipal Public Market has been instituted by the local government; however, the project further requires additional works and funding to be completed in order to maximize utilization, comfort and convenience of the public;

WHEREAS, Health and Sanitation programs particularly the provision of sanitary toilets to identified households is considered a priority in response to the call of the national government through the Department of Health for LGUs to address issues on health and sanitation to promote the general welfare of the people within their jurisdictions;
