RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A DEED OF DONATION AND AGREEMENT OF SUBDIVISION WITH TERESITA TUPAS-GARVILLES FOR THE ACQUISITION OF A PARCEL OF LAND KNOWN AS LOT 927-A-2-V, CONTAINING AN AREA OF 272 SQ. M. MORE OR LESS, SITUATED AT POBLACION, TIGBAUAN, ILOILO
