**Resolution No. 2015-071**

RESOLUTION APPROVING THE COMPROMISE AGREEMENT IN ADMINISTRATIVE COMPLAINT NO. SB 01-2015 ENTITLED “CHRISTY TAMAYO VS. EUGENIO TIGRES”.

WHEREAS, on February 16, 2015 Christy T. Tamayo (“complainant”) filed with this August Body an administrative complaint dated February 13, 2015 against Eugenio Tigres (“respondent”), Punong Barangay of Barangay Parara Norte, this Municipality, for Abuse of Authority, Oppression, Misconduct in Office and Gross Negligence or Dereliction of Duty, later docketed as **Administrative Case No. SB 01-2015**;

WHEREAS, during the regular session on February 18, 2015, the council found the complaint *sufficient in form and substance* pursuant to the provisions of **Municipal Ordinance No. 2008-006** which governs the procedure in Administrative Cases Against Elective Barangay Officials;

WHEREAS, after the respondent filed his Answer, the council in its regular session on March 11, 2015, determined that *probable cause* exists that would warrant an investigation;

WHEREAS, during the regular session on March 20, 2015, the council by a majority vote created the Ad Hoc Committee that will conduct the investigation composed of the following: **Hon. Virgilio T. Teruel**, Chairman of the Committee on Good Government (Chairman), **Hon. Jose Donel T. Trasporto** (Member) and **Hon. Ronnie Paguntalan** (Member);

WHEREAS, during the regular session on March 25, 2015, the council revised the composition of the Ad Hoc Committee since Hon. Ronnie Paguntalan is an *ex-officio* member and not a *regular* or *elected* member of the Sanggunian as required by Municipal Ordinance No. 2008-006 and by a majority vote elected **Hon Renee L. Valencia** to take the place of Hon. Paguntalan as Member of the Ad Hoc Committee;

WHEREAS, during the formal investigation on May 21, 2015, the parties, assisted by their counsels, submitted to the Committee a **Compromise Agreement** that would lead to the withdrawal/dismissal of the complaint;

WHEREAS, **Municipal Ordinance No. 2008-006** mandates that “the Committee shall encourage the parties and their counsels to enter, at any stage of the proceedings, into amicable settlement, compromise or arbitration, *the terms and conditions of which shall be subject to the approval of the Sanggunian*”. (Section 6 (c))

WHEREAS, during the regular session on May 27, 2015, the Committee submitted its Report on its investigation where it found the terms and conditions of the Compromise Agreement not contrary to law, morals, good customs, public order and public policy, would put closure to this case and, more importantly, would remove distractions and bring back harmony to the barangay officials of Barangay Parara Norte towards better public service to their constituents, and therefore recommended for its approval by the August Body.

NOW, THEREFORE, upon motion of, HON. VIRGILIO TERUEL, *Chairman, Committee on Good Government, Public Ethics & Accountability and Ad Hoc Committee on Administrative Case No. SB 01-2015* and duly seconded by Hon. Renee Librodo-Valencia, Hon Marlon Teruñez, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan;

RESOLVED, AS IT IS HEREBY RESOLVE, to APPROVE the Compromise Agreement by the complainant and respondent in Administrative Case No. SB 01-2015,

RESOLVED FURTHER, to furnish CHRISTY T. TAMAYO (complainant), Hon. EUGENIO TIGRES (respondent), Hon. SUZETTE TENEFRANCIA-ALQUISADA, Municipal Mayor, and Mrs. GENEFER A. SABIO (MLGOO Tigbauan, Iloilo) with copies of this Resolution.
