RESOLUTION CONFORMING AND ADOPTING MDC-EXECUTIVE COMMITTEE RESOLUTION NO. 2015-001 *"RESOLUTION IDENTIFYING THE UTILIZATION OF THE APPROPRIATION FOR THE REHABILITATION OF FARM TO MARKET ROADS AS ADDITIONAL FUND FOR THE PURCHASE OF HEAVY EQUIPMENT."*

Whereas, the MDC Executive Committee (MDC-ExeCom) in its June 10, 2015 meeting at the Office of the Mayor passed Resolution No. 2015-001, identifying the utilization of the appropriation for the rehabilitation of farm to market roads as additional fund for the purchase of heavy equipment;

Whereas, to ensure continuous and more effective rehabilitation, improvement and maintenance of farm to market roads in response for the various needs of its constituents it was established that the Local Government Unit of Tigbauan must provide the heavy equipment;

Whereas, upon consultation and deliberation, it was determined that there is a need to acquire one unit Road Grader and one unit Road Roller amounting to more or less Eight million Pesos (Php 8,000,000.00) to sustain the FMR rehabilitation project;

Whereas, available funds for the acquisition of heavy equipment appropriated for FY 2015 is Six million pesos (Php 6,000,000.00) under Capital Outlay, Office of the Mayor;

Whereas, under MDC-ExeCom Resolution No. 2015-001, the additional funds necessary for the acquisition of aforesaid heavy equipment shall be taken from the following appropriations:

Php	1,590,000.00	FY 2015 20% IRA for FMR Rehabilitation
	410,000.00	FY 2014 20% IRA for FMR Rehabilitation;

Whereas, the utilization of FMR rehabilitation funds for the acquisition of the aforesaid heavy equipment under MDC-ExeCom Resolution No. 2015-001 aims to further stimulate the growth and development of agriculture, enhance economic prosperity, promote full employment, support the development of appropriate and self reliant scientific and technological capabilities and preserve comfort and convenience of our constituents, for which local governments are mandated to pursue under the Section 16 (General Welfare) of the Local Government Code;
