RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO CERTIFY THAT THE LOCAL GOV'T UNIT OF TIGBAUAN ALLOWS THE CONSTRUCTION OF ONE (1) UNIT BUILDING OF DAY CARE CENTER WITH AMENITIES ON A PORTION OF LOT NO. 458-M-1 LOCATED AT TEJERO ST., BRGY. 9 POBLACION, TIGBAUAN, ILOILO

WHEREAS, Barangay 9, Poblacion has identified the Construction of one (1) unit Day Care Center as one of their priority projects under the KALAH-CIDSS Program of the government;
