RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPED DISTRICT OF TIGBAUAN, BRGY. 9, AND THE ORIGINAL OWNERS OF LOT NO 458-M-1, LOCATED AT TEJERO ST., TIGBAUAN, ILOILO FOR THE CONSTRUCTION OF ONE (1) UNIT BUILDING OF DAY CARE CENTER WITH AMENITIES THEREIN.

WHEREAS, Barangay 9, Poblacion has identified the Construction of one (1) unit Day Care Center as one of their priority projects under the KALAHI-CIDSS Program of the government;

WHEREAS, said barangay was able to find out that a lot located within their territorial jurisdiction identified as Lot No 458-M-1 which was formerly owned by the family of former Mayor Celso Ledesma has been donated to the Municipality of Tigbauan;

WHEREAS, the only available proof of donation, however, is a Joint Affidavit signed by former Mayor Celso Ledesma as donor and then Mayor Benjamin Taasan for and in behalf of the municipality of Tigbauan as Donee;

WHEREAS, said lot is identified to be the only available site for the construction of a Day Care Center, which is however included within the perimeter fence of the Tigbauan Central Elementary School under the DepEd-District of Tigbauan;

WHEREAS, despite the fencing however, the lot occupied by the Tigbauan Central Elementary School, however, remains to be untitled;

WHEREAS, to place everything into proper perspective, the Sangguniang Bayan of Tigbauan realizes the collective commitment of all stake-holders for the success in the implementation of this noble government project;
