RESOLUTION EXPRESSING HEARTFELT THANKS AND GRATITUDE TO THE FAMILY OF THE LATE FORMER MAYOR CELSO LEDESMA FOR THEIR BENEVOLENCE AS DONORS OF LOT NO. 458-M-1 LOCATED AT BARANGAY 9, POBLACION FOR THE CONSTRUCTION OF ONE (1) UNIT DAY CARE CENTER WITH AMENITIES AND AS FUTURE SCHOOL SITE FOR THE USE OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the municipality is one of the recipients of the KALAH-I-CIDSS program of the DSWD and one of the approved sub-projects is the construction of one unit Day Care Center with amenities in Barangay 9 Poblacion, Tigbauan, Iloilo;

WHEREAS, while on the process of complying with the requirements for the said project, it was found out that the proposed location, which is a portion of Lot No. 458-M-1 located at Tejero Street, Barangay 9 Poblacion, Tigbauan, Iloilo is owned by the Republic of the Philippines under Tax Declaration 1508 registered in the Office of the Municipal Assessor of Tigbauan, Iloilo;

WHEREAS, further research led to the discovery of a Joint Affidavit executed by **BENJAMIN F. TA-ASAN** and **CELSO LEDESMA** recorded as Document No. 6, Page 3, Book X, Series of 1986 in the Notarial Book of Jose T. Tuvida, Notary Public which provides among others that:

***“ x x x That for and in behalf of the Municipality of Tigbauan, Province of Iloilo, Philippines, (Benjamin F. Ta-asan) have accepted and received the donation of ONE THOUSAND TWO HUNDRED SIXTY ONE (1,261) SQUARE METERS, more or less as school site and SIX HUNDRED EIGHTEEN (618) SQUARE METERS, more or less, as Right of Way or a total of ONE HUNDRED EIGHT HUNDRED SEVENTY NINE (1,879) SQUARE METERS, more or less, which is in accordance with the Transfer Certificate of Title No. 79641, and have expressed the Municipality’s appreciation and gratefulness for the kindness and generosity of MR. CELSO LEDESMA. x x x”;***

WHEREAS, the said document clearly appears to be a donation made by former Mayor Celso Ledesma to then Mayor of the Municipality of Tigbauan, Benjamin Ta-asan of the above mentioned parcel of land to be used as school site, in which the Municipality of Tigbauan through the local Sanggunian deems it necessary that such noble act of kindness on the part of former Mayor Celso Ledesma and his family be given due recognition as our way of showing our profound sense of gratitude;

WHEREAS, the said donation has been beneficial to the people of Tigbauan considering that it is presently occupied and used as school site of Tigbauan Central Elementary School and will also soon be the site of a new Day Care Center with amenities, all geared towards the promotion of quality and accessible education and for the general welfare of our children, our future;

WHEREAS, the people of Tigbauan will forever be grateful for this benevolence and this shall surely inspire everyone to become beacons of hope and trail blazers of a brighter tomorrow by helping one another in creating a better hometown and by working together as one for one Tigbauan;
