RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRENCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MUNICIPALITIES OF THE FIRST DISTRICT OF ILOILO FOR THE CREATION OF AN ALLIANCE, KNOWN AS **DISASTER RISK REDUCTION AND MANAGEMENT FIRST ILOILO RESPONSE SUPPORT TEAM (D'FIRST)**.

WHEREAS, it is a declared policy of the State to adopt a disaster risk reduction and management approach that is holistic, comprehensive, integrated, and proactive in lessening the socioeconomic and environmental impacts of disasters including climate change, and promote the involvement and participation of all sectors and all stakeholders concerned, at all levels, especially the local community;

WHEREAS, recognizing the high disaster risk of the seven (7) Municipalities of the First District of Iloilo, it is imperative to develop a comprehensive strategy that aims to strengthen the capacity of the first congressional district LGUs together with partner stakeholders, to build the disaster resilience of communities, and to institutionalize arrangements and measures for reducing disaster risks, including projected climate risks, and enhancing disaster preparedness and response capabilities at all levels;

WHEREAS, to promote mutual support between and among the seven (7) municipalities through better partnership and working relationship, it is deemed necessary to create an alliance in relation to disaster risk reduction and management of the First District of Iloilo;

WHEREAS, the organization of an alliance is in line with the mandate of Republic Act 10121 to recognize and strengthen the capacities of LGUs and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters, as well as to establish linkage/network with other LGUs for disaster risk reduction and emergency response purposes;

WHEREAS, as per consensus decision by the seven (7) Local Chief Executives comprising the First Congressional District of Iloilo, an alliance is hereby organized aptly dubbed as **Disaster Risk Reduction and Management First Iloilo Response Support Team**, also known as **D'FIRST**;

WHEREAS, D’FIRST shall be composed of Municipal Mayors, MDRRMOs, MPDOs, Fire Marshals, COPs, LnB Presidents, RHU and hospital personnel, school heads, MSWDOs, Civil Society Organizations, responders of the First District of Iloilo, and other stakeholders;

WHEREAS, for and in consideration of the above-stated premises, parties hereby agree to undertake the herein commitments to create an alliance, herein referred to as D’FIRST, in accordance with the following terms, conditions and stipulations:

Responsibilities of each LGU:

- 1. Adhere to the vision, mission, and objectives of D’ FIRST;
- 2. Coordinate disaster risk reduction and management activities, responsive to the needs of the local level;
- 3. Consolidate local disaster risk information which includes natural hazards, vulnerabilities, and climate change risks;
- 4. Identify and implement cost-effective risk reduction measures/strategies;
- 5. Shall appropriate funds in the amount of Fifty Thousand Pesos (P50,000.00) as Trust Fund of the alliance, to be remitted to LGU Guimbal;
- 6. Regularly attend meetings, conferences, and activities of D’FIRST;

NOW, THEREFORE, on motion of HON. RICKY T. NULADA and duly seconded by Hon Renee Librodo-Valencia, Hon. Jose Donel Trasporto, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan,

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement With The Municipalities Of The First District Of Iloilo For The Creation Of An Alliance, Known As Disaster Risk Reduction And Management First Iloilo Response Support Team (D’FIRST),

RESOLVED FURTHER, to furnish copies of this Resolution to Mayor Suzette Tenefrancia-Alquisada, this municipality, and to all concerned Municipalities of the 1st District of Iloilo for their information and/or appropriate action.
