**Resolution No. 2015-083**

**RESOLUTION GRANTING AUTHORITY TO MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FOR THE TRANSFER OF FUNDS IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED THOUSAND PESOS (P1,800,000.00) FOR THE IMPLEMENTATION OF EXPANDED AID TO INDIVIDUALS IN CRISIS SITUATION (AICS)**

**WHEREAS**, the Assistance to Individuals in Crisis Situation (AICS) is part of the DSWD’s protective services for the poor, marginalized and vulnerable / disadvantaged individuals. The AICS has been implemented by the DSWD for decades, as part of its technical assistance and resource augmentation support to LGUs and other partners;

**WHEREAS**, the AICS included among others a wide range of services such as immediate rescue and provision of direct financial assistance , psycho-social support, and material assistance including medical, transportation, financial, burial, and other services;

**WHEREAS**, historical data shows that there has been an increasing number of AICS clients and based on profile, most of them come from remote areas and regional centers , hence the need to strengthen and enhance the existing internal delivery system to benefit the poor, marginalized, vulnerable/disadvantaged individuals/families in the locality;

**WHEREAS**, Tigbauan being a 2<sup>nd</sup> Class Municipality located in the southern part of Iloilo or the First Congressional District with a total population of 63, 520 and 13,291 households, is among the local government units with an increased number of AICS clientele;

**WHEREAS**, the transfer of fund to our LGU for the implementation of expanded Assistance to Individuals in Crisis Situation will help these families access financial assistance immediately to qualified clients.

**NOW THEREFORE**, on motion of Hon. Ma. Gerrylin Santuyo-Camposagrado, Chairperson, Committee on Education, Women and Family, Social Services and Senior Citizens, and duly seconded by Hon. Renee Librodo-Valencia, Hon. Ricky T. Nulada and Hon. Ariel Bernardo,

**BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to grant authority to Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada for and in behalf of the Municipality of Tigbauan, to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development for the transfer of funds in the amount of One Million Eight Hundred Thousand Pesos (P1,800,000.00) for the implementation of Expanded Aid to Individuals in Crisis Situation (AICS).
