Resolution No. 2015-084

RESOLUTION GRANTING AUTHORITY TO MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA- ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FOR THE SUPPLEMENTAL FEEDING PROGRAM.

WHEREAS, most recent data from the 7th National Nutrition Survey (2008) conducted by the Food and Nutrition Research Institute of the Department of Science and Technology revealed that prevalence of under and over nutrition still persists among Filipino children and has significantly increased as compared to the last survey;

WHEREAS, the Department of Social Welfare and Development, in its mandate to provide social welfare and development programs particularly through technical assistance and resource augmentation, is providing nutrition services to its clients at the local level through the center-based and community-based services in partnership with Non-Government Organization under the Program Management Bureau, such as the Food for School and Healthy Start Feeding Program in day care centers which were previously implemented nutrition programs of the Department;

WHEREAS, though malnutrition among children is a problem that needs to be addressed by the government, children who are at-risk of malnutrition should also be given equal consideration to prevent them from becoming malnourished;

WHEREAS, the "Supplemental Feeding Program" is the provision of food in addition to the regular meals, to currently enrolled day care children as part of the DSWD's contribution to the Early Childhood Care and Development (ECCD) program of the government;

WHEREAS, the MSWDO shall be responsible for providing administrative and technical assistance in the operationalization of the SFP and ensure that funds intended for the program shall be used solely for the latter's operation in their respective day care centers;

WHEREAS, the LGU-Tigbauan undertakes to implement the Supplemental Feeding Program based on the agreement with the DSWD, liquidate all funds transferred and consolidate reports and profiling of children beneficiaries;

NOW, THEREFORE, on motion of Hon. Ma. Gerrylin Santuyo-Camposagrado, Chairperson, Committee on Education, Women and Family, Social Services and Senior Citizens, and duly seconded by Hon. Ricky T. Nulada and Hon. Ariel Bernardo,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED to grant authority to Municipal Mayor, Atty. Suzette Tenefrancia- Alquisada for and in behalf of the Municipality of Tigbauan, to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development for the Supplemental Feeding Program.

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Mayor Suzette Tenefrancia-Alquisada and to all concerned for their information and/or appropriate favorable action.
