LACSON FOUNDATION MARITIME UNIVERSITY – AREVALO, INC. FOR THE 3RD YEAR OF THE BUSOG, LUSOG, TALINO FEEDING PROGRAM AT SIPITAN ELEMENTARY SCHOOL AND CANABUAN ELEMENTARY SCHOOL.

WHEREAS, a Memorandum of Agreement was entered into by and between the LGU Tigbauan and the John B. Lacson Foundation Maritime University Arevalo and the DepEd Division of Iloilo last June 1, 2013 for the program implementation of the Busog, Lusog, Talino Program;
