RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE OFFICE OF THE GOOD GOVERNOR, HON. ARTHUR DEFENSOR, SR., PROVINCE OF ILOILO FOR THE REPAIR OF NAGBA HANGING BRIDGE IN THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (P800,000.00).

WHEREAS, hanging bridge of Barangay Nagba, crossing Tacuyong River, in the Municipality of Tigbauan constructed some decades ago is already dilapidated and worn out, thus badly needing immediate attention and repairs;

WHEREAS, said hanging bridge is a major alternative passage of the people during rainy days especially when the Tacuyong River overflows;

WHEREAS, the unsafe and dilapidated condition of the said hanging bridge could compromise the welfare of the people not only for possible accidents but also because it hampers the continuous and prompt access of our constituents and their produce to major thoroughfares;

WHEREAS, the immediate repair of this bridge will be greatly appreciated by the inhabitants of the affected barangays having promoted their comfort and convenience, enhanced health and safety, and provided ease in bringing agricultural produce to the markets, thus supporting their agricultural, economic and livelihood activities;
