**Resolution No. 2015-095**

RESOLUTION DESIGNATING HON. RENEE LIBRODO-VALENCIA, ACTING MUNICIPAL MAYOR, FOR THE PERIOD AUGUST 27, 2015 TO SEPTEMBER 16, 2015 AS ONE OF THE OFFICIAL SIGNATORIES IN ALL OFFICIAL TRANSACTIONS WITH THE LAND BANK OF THE PHILIPPINES (LBP), DEVELOPMENT BANK OF THE PHILIPPINES (DBP), AND PHILIPPINE VETERANS BANK (PVB), IN LIEU OF MAYOR SUZETTE T. ALQUISADA AND VICE MAYOR ROEL T. JARINA, WHO WILL BE ON OFFICIAL TRAVEL TO CALIFORNIA, U.S.A.

WHEREAS, Atty. Suzette T. Alquisada, Municipal Mayor issued on July 17, 2015, Executive Order No. 023, Series of 2015 with the Subject: *"An Order Designating Hon. Renee Librodo Valencia, Sangguniang Bayan Member, as Acting Mayor For The Period August 27 to September 16, 2015;"* in view of her Travel *(as guest of honor extended by the Tigbauan Association of California, U.S.A. to the Benefit Dinner Ball on September 5, 2015 at Double Tree Hilton in Torrance, California, U.S.A.)*;
