RESOLUTION ADOPTING AND CONFIRMING THE SUPPLEMENTAL BUDGET OF THE LOCAL SCHOOL BOARD OF THE MUNICIPALITY OF TIGBAUAN, APPROPRIATING THE SURPLUS IN THE 2014 SPECIAL EDUCATION FUND IN THE AMOUNT OF ONE MILLION TWO HUNDRED TWENTY THOUSAND (P1,220,000.00) FOR THE COMPLETION OF THE TEEN CENTER, REPAIR AND MAINTENANCE OF SCHOOL FACILITIES AND SPORTS DEVELOPMENT.

WHEREAS, the approved budget of the Local School Board for the year 2015 was only in the amount of One Million Two Hundred Twenty Thousand Pesos (P1,220,000.00);

WHEREAS, it was found out that the budgeted amount will never be enough to meet the needs of the different schools in the Municipality of Tigbauan;

WHEREAS, the Local Finance Committee has certified to the availability of surplus in the Special Education Fund in the amount of One Million Two Hundred Twenty Thousand Pesos to be available for supplemental budgeting;

WHEREAS, the Local School Board has approved the amount of P500,000.00 for the Completion of the Teen Center, P120,000.00 for the Repair and Maintenance of the School Facilities and the amount of PP600,000.00 for Sports Development, for a total of P1,220,000.00;
