RESOLUTION APPROVING THE SUBDIVISION APPROVAL NO. SA-08-15-303 OF MA. LENY MALCONTENTO ET. AL. WITH TCT NO. F-23583 LOT NO. 1886, WITH AN AREA OF 2,014 SQ. M. MORE OR LESS, CONTAINING THREE (3) LOTS LOCATED AT BRGY. BITAS, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application of Ma. Leny Malcontento Et-Al with Subdivision Approval No. SA-08-15-303 with TCT No. F-23583 Lot No. 1886, with an area of 2,014 sq. m. more or less, containing three (3) lots located at Brgy. Bitas, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on August 24, 2015 for authorization and approval;

WHEREAS, the purpose/intent of this application is to sell,

WHEREAS, the said parcel of land is identified in the built-up area/residential area in the zoning classification;

- a.) In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b.) Comply with all the corrections as indicated on the plan;
- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.
