Resolution No. 2015 – 114

RESOLUTION APPROVING THE HOLDING OF COCKFIGHTING AT BARANGAY CORDOVA SUR, THIS MUNICIPALITY.

WHEREAS, Barangay Cordova Sur had forwarded to this August Body their Resolution No. 32-2015 – entitled: *“Resolution Requesting The Good Office Of The Sangguniang Bayan Of Tigbauan, Iloilo For The Approval To Hold A Three (3) Days Cockfighting Event On October 21-23, 2015 At Barangay Cordova Sur, Tigbauan, Iloilo In Connection Of Our Barangay Annual Fiesta”*;

WHEREAS, on December 26, 2013, this August Body passed Municipal Ordinance No. 2013-005, entitled: *“AN ORDINANCE GRANTING A.P. TENDERO SPORTS ARENA-GALLERA DE TIGBAUAN, A FRANCHISE TO ESTABLISH, MAINTAIN AND OPERATE A COCKPIT IN THE MUNICIPALITY OF TIGBAUAN”*;

WHEREAS, on December 27, 2013 said ordinance was forwarded to the Sangguniang Panlalawigan for review and the same was returned and declared as legal and valid;

WHEREAS, Sec. 7.2, Sec. 7.3 & Sec. 7.4 of said ordinance provide:

“**Section 7.2.** In the absence of licensed cockpit in the barangay, cockfighting maybe allowed during the celebration of barangay annual fiesta for not more than three (3) days to be held in the place provided for cockfighting; Provided, however, that Sangguniang Bayan resolution and Mayor’s permit shall be secured prior to the scheduled cockfighting. In the event of conflict of schedule of cockfighting between the licensed cockpit and the barangay, the former shall prevail and the barangay cockfight shall be held before or after the scheduled cockfight in the licensed cockpit;

Section 7.3 Prerequisites Of Holding Cockfighting In The Barangay. Barangay concerned shall be responsible in processing all the requirements needed in conducting cockfighting in the barangay. Two (2) weeks before the holding of cockfighting, concerned barangay shall pass a resolution addressed to the Sanggunian Bayan and copy furnished the cockpit franchisee for proper action and/or approval. Only upon approval of the cockpit franchisee and the Sangguniang Bayan, the barangay shall process their Mayor’s permit and pay corresponding fees at the Municipal Treasurer’s Office.

Section 7.4. Only licensed cockpit personnel shall administer the cockfighting in the franchise cockpit and in every barangay fiesta celebration with the presence of one (1) personnel from the Municipal Treasurer’s Office.”

WHEREAS, this August Body hereby approves the conduct of such activity subject to compliance by the barangay concerned of the said ordinance particularly with regard to the aforementioned provisions;

WHEREAS, non-compliance of the requirements on the part of Barangay Cordova Sur concerned shall be sufficient cause for the cancellation of this approval and/or legal action;

NOW, THEREFORE, on motion of HON. RONNIE PAGUNTALAN, *Chairman, Committee on Barangay Affairs* and duly seconded by Hon. Jose Donel Trasporto, Hon. Virgilio Teruel, Hon. Marlon Teruñez, Hon. Ma. Gerrylin Santuyo – Camposagrado, Hon. Suzette Marie Hilado – Banno Hon. Ricky Nulada and Hon. Ariel Bernardo;

RESOLVED, to approve the Holding Of Cockfighting At **Barangay Cordova Sur**, This Municipality,

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, this municipality, to **Barangay Cordova Sur** and all concerned for their information and/or appropriate action.
