RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANICA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT BETWEEN THE DEPARTMENT OF HEALTH-REGIONAL OFFICE VI AND MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO FOR THE PROJECT: *“SANITARY TOILET FOR TOILETLESS HOUSEHOLDS OF THE MUNICIPALITY”*.

WHEREAS, the Municipality of Tigbauan is a 2nd class municipality located in the Southern part of the Province of Iloilo. It has a total of 52 barangays, 9 barangays of which are located in the poblacion and the rest are scattered around the poblacion and spread up to the boundaries of the Municipalities of Oton, San Miguel, Leon and Guimbal;

WHEREAS, the Rural Health Unit, serves as the main health center that caters health services to more or less 63,000 plus population from the 14 catchment areas covering 13,291 households. The facility was accredited by Philhealth from 2013 up to the present (PCB1 and TBDOTS) implementing all DOH Program Thrusts particularly included in the Aquino Health Agenda and realization of the Millennium Development Goals;

WHEREAS, the Rural Health Unit is manned by 2 physicians, 3 public health nurses, 14 RHM’s, 1 Dentist, 1 Dental Aide, 1 Medical Technologist, 3 Sanitary Inspectors, 2 Administrative Aides, 3 Ambulance Drivers, 4 Job Order Personnel, 8 NDPs, 2 RHMPPs and 464 active Barangay Health Workers;

WHEREAS, as of December 2014, there are 199 NHTS households in this municipality with no sanitary toilets and that the DOH Regional Office VI provided financial assistance in the amount of P100,000 to augment the same;

NOW, THEREFORE, on motion of VICE MAYOR ROEL T. JARINA, Chairman, Committee on Health and Sanitation and duly seconded by Hon. Jose Donel Trasporto, Hon. Renee Librodo-Valencia, Hon. Virgilio Teruel, Hon. Marlon Teruñez, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefranca-Alquisada For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement Between The Department Of Health-Regional Office VI And Municipality Of Tigbauan, Province Of Iloilo For The Project: "*Sanitary Toilet For Toiletless Households Of The Municipality*",
