RESOLUTION CONFORMING AND APPROVING THE CY 2016 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF **BARANGAYS PARARA NORTE, 4 (POBLACION), BAROSONG, AND LUBOG**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on November 23, 2015, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2016 Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the following barangays:

***Barangay Parara Norte** CY 2016 General Annual Budget Involving an Appropriation of P2,022,945.00, 20% Development Fund in the amount of P391,889.00, and 5% BDRRMF in the amount of P101,147.25 Approved by Sangguniang Barangay on July 27, 2015 and Enacted Under Appropriation Ordinance No. 2015-001;*

***Barangay 4 (Poblacion)** CY 2016 General Annual Budget Involving an Appropriation of P1,401,931.00, 20% Development Fund in the amount of P251,438.20, and 5% BDRRMF in the amount of P63,784.55 Approved by Sangguniang Barangay on September 4, 2015 and Enacted Under Appropriation Ordinance No. 2015-003;*

***Barangay Barosong** CY 2016 General Annual Budget Involving an Appropriation of P1,570,742.00, 20% Development Fund in the amount of P304,048.40, and 5% BDRRMF in the amount of P78,537.10 Approved by Sangguniang Barangay on October 19, 2015 and Enacted Under Appropriation Ordinance No. 2015-02;*

***Barangay Lubog** CY 2016 General Annual Budget Involving an Appropriation of P1,162,745.00, 20% Development Fund in the amount of P227,148.20, and 5% BDRRMF in the amount of P58,137.25 Approved by Sangguniang Barangay on July 27, 2015 and Enacted Under Appropriation Ordinance No. 2015-01;*

WHEREAS, the Municipal Budget Officer had reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance

with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan,
