Resolution No. 2015-138

RESOLUTION COMMENDING THE TIGBAUAN PNP STATION PERSONNEL HEADED BY POLICE INSPECTOR HERMOGENES E. EULATIC WHO WERE INSTRUMENTAL TO THE ARREST OF THE NO. 4 MOST WANTED PERSON IN THE PROVINCE OF ILOILO AND FOR OTHER SIGNIFICANT ACCOMPLISHMENTS.

WHEREAS, upon information and thru the efforts and initiative of the **TIGBAUAN PNP STATION PERSONNEL HEADED BY POLICE INSPECTOR HERMOGENES E. EULATIC**, last June 29, 2015, the **No.4** Most Wanted Person in the Province of Iloilo, in the person of Mr. Armando Tayoba, Jr. y Taghap, (37 years old, single, farm caretaker, and a resident of Brgy. Bantud, Tigbauan, Iloilo, accused for the crime of Robbery with Homicide per Criminal Case No. 2329 dated September 3, 2012 under the sala of Hon. Nelson J. Bartolome, Assisting Judge, RTC, 6th Judicial Region, Branch 67 Guimbal, Iloilo) was arrested by the PNP Members of Sta. Maria Police Station, Bulacan and was turned over to the Tigbauan Police Station on November 17, 2015;

WHEREAS, on September 22, 2015 at around 10:00 P.M., **THE MEMBERS OF THE TIGBAUAN ANTI-ILLEGAL DRUGS SPECIAL OPERATION TASK GROUP** led also **BY PINSP HERMOGENES E. EULATIC, TOGETHER WITH SPO1 GIL JOEL TARDAGUELA, PO1 JEFFREY TALAVER, AND PO1 GLENN MARK ABAYON** conducted a buy-bust operation at Brgy. Tan Pael, this Municipality and this resulted to the apprehension of MR. NOLLY CASTOR y TALAYRE, (**No. 3** in the Illegal Drugs Watchlist of the municipality), and the recovery and confiscation of **eight (8) pieces heat sealed transparent plastic sachet containing suspected "shabu", marked money, two (2) units cellphones, one (1) Ipod, one (1) lighter, one (1) malboro and one (1) head set;**

WHEREAS, in relation to the implementation of the Lambat Sibat Patrol Plan 2030 and Directive from RD PPO6 dated October 26, 2015 (re: Conduct of One Time Big Time Operation

against All Forms of Illegal activities), another buy-bust operation was conducted on October 29, 2015 at around 11:30 A.M by the same Group., headed by **PINSP HERMOGENES E. EULATIC**,

TOGETHER WITH SPO1 GIL JOEL TARDAGUELA, PO1 JAMES BARCELONA, PO1 RALPH TUPAS, PO1 JAY TEJADO, AND PO1 ARCHIE NACION AT BRGY. NAMOCON, THIS MUNICIPALITY, which also led to the arrest of MR. RAMON TAYO y TORRES, (**No. 1**, in the *Illegal Drugs Watchlist of the municipality*), and the recovery and confiscation of the following: *three (3) pieces heat sealed transparent plastic sachets with white crystalline substance containing suspected “shabu”, fourteen (14) pieces small elongated heat sealed transparent plastic sachets with white crystalline substances also containing suspected “shabu”, assorted suspected drug paraphernalias, marked money, one (1) unit cellphone, etc.;*

WHEREAS, such accomplishments are worthy of commendation considering the ill effects of crimes and illegal drugs in our society;

WHEREAS, the Local Government Unit recognizes the efficient and active participation of the police force in securing a peaceful and orderly community;

WHEREAS, the courage, dedication and hard work of Tigbauan PNP can serve as inspiration for other stakeholders to help solve and take active part in minimizing the commission of crimes and the negative effects of drug-related problems in this municipality;

WHEREAS, such achievements merit the award of Five Thousand Pesos (P5,000.00) from the LGU Tigbauan to further boost the morale of the Tigbauan PNP Personnel and Staff;

NOW, THEREFORE, on motion of HON. RICKY NULADA, *Chairman, Committee on Peace & Order and Pubic Safety* and duly seconded by Hon. Jose Donel Trasporto, Hon. Marlon Teruñez, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan;

RESOLVED, to commend the Tigbauan PNP Station Personnel Headed by Police Inspector Hermogenes E. Eulatic who were instrumental to the Arrest of the No.4 Most Wanted Person In The Province Of Iloilo, and their other Significant Accomplishments;

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, this municipality, to PNP Tigbauan Police Station, and to all concerned for their information.
