RESOLUTION APPROVING THE COMPREHENSIVE DEVELOPMENT PLAN (CDP) 2016-2021 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Comprehensive Development Plan of the Municipality of Tigbauan, Iloilo Province fulfills one of the mandates of Local Government Units (LGUs) that is to prepare a multi-year socio-economic development plan and investment programs (RA 7160, Sec. 109). Ideally, the CDP is formulated after the Comprehensive Land Use Plan and Zoning to serve as one of the implementing instruments;

WHEREAS, the formulation of the CLUP and of this CDP took place as a continuous process to ensure the essential connection between the long-term framework plan (CLUP) and the medium-term action plan (CDP), the policy framework embodied in the CLUP has guided the identification of programs and projects in this CDP;

WHEREAS, the Comprehensive Development Plan (CDP) is a six (6) year plan, a multi-sectoral development plan to serve as guide by the Local Government Unit in its planning and budgeting process, sectoral goals and objectives, issues and concerns, strategies and recommendations, programs and projects of five development sectors such as Social Development, Economic Development, Physical/Land Use and Infrastructure Development, Environmental Management and Institutional Development;

WHEREAS, the ultimate goal of this plan is to improve the state of well-being of the people and to improve the delivery of basic services, especially the quality of social services such as health and sanitation, education, peace and order and social welfare including economic development, infrastructure, maintaining cleanliness of air, water and land resources and strengthening the capability of the LGU to plan and manage the development growth of this municipality;
