RESOLUTION CONFORMING AND APPROVING THE CY 2016 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF **BARANGAYS BUENAVISTA, 9 (POBLACION), TAN PAEL, NAPNAPAN NORTE, NAGBA, ATABAYAN, ISIAN, 1 (POBLACION), CANABUAN, SIPITAN, GUISIAN, BARROC, LINOBAYAN, DORONG-AN, BANTUD, BINALIUAN MENOR, SAN RAFEL AND ISAUAN**, THIS MUNICIPALITY.

Barangay Dorong-an CY 2016 General Annual Budget Involving an Appropriation of P2,129,209.00, 20% Development Fund in the amount of P421,841.80, and 5% BDRRMF in the amount of P106,460.45 Approved by Sangguniang Barangay on September 6, 2015 and Enacted Under Appropriation Ordinance No. 2015-03;

Barangay Bantud CY 2016 General Annual Budget Involving an Appropriation of P1,113,714.00, 20% Development Fund in the amount of P220,562.80, and 5% BDRRMF in the amount of P55,685.70 Approved by Sangguniang Barangay on October 18, 2015 and Enacted Under Appropriation Ordinance No. 2015-01;

Barangay Binaliuan Menor CY 2016 General Annual Budget Involving an Appropriation of P1,289,070.00, 20% Development Fund in the amount of P255,614.00, and 5% BDRRMF in the amount of P64,453.50 Approved by Sangguniang Barangay on September 20, 2015 and Enacted Under Appropriation Ordinance No. 2015-01;

Barangay San Rafael CY 2016 General Annual Budget Involving an Appropriation of P1,077,012.00, 20% Development Fund in the amount of P214,402.40, and 5% BDRRMF in the amount of P53,850.60 Approved by Sangguniang Barangay on December 6, 2015 and Enacted Under Appropriation Ordinance No. 2015-01;

Barangay Isauan CY 2016 General Annual Budget Involving an Appropriation of P1,042,212.00, 20% Development Fund in the amount of P206,542.40, and 5% BDRRMF in the amount of P52,110.60 Approved by Sangguniang Barangay on October 7, 2015 and Enacted Under Appropriation Ordinance No. 2015-001;

WHEREAS, the Municipal Budget Officer had reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;
