RESOLUTION CONFORMING AND APPROVING THE CY 2015 SUPPLEMENTAL BUDGETS OF BARANGAYS NAPNAPAN SUR, PARARA NORTE, LANAG, BAYUCO, BAGUMBAYAN, JAMOG, 5 (POBLACION), BITAS, ALUPIDIAN, DANAOG, TARO, DORONG-AN, LUBOG, BINALIUAN MENOR, PARARA SUR, 6 (POBLACION), CANSILAYAN, NAMOCON, BINALIUAN MAYOR, NAGBA, BANGKAL, 2 (POBLACION), BUENAVISTA AND CANABUAN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on December 9 and 14, 2015 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2015 Supplemental Budgets embodying Appropriation Ordinances of the following barangays:

**Brgy. Napnapan Sur** Supplemental Budget No. 2015-01 for CY 2015, involving an Appropriation of P98,467.48 and was approved by the Sangguniang Barangay on November 2, 2015.

**Brgy. Parara Norte** Supplemental Budget No. 2015-01 for CY 2015, involving an Appropriation of P108,118.00 and was approved by the Sangguniang Barangay on December 1, 2015.

**Brgy. Lanag** Supplemental Budget No. 2015-01 for CY 2015, involving an Appropriation of P51,989.59 and was approved by the Sangguniang Barangay on November 9, 2015.

**Brgy. Lubog** Supplemental Budget No. 2015-01 for CY 2015, involving an Appropriation of P65,487.00 and was approved by the Sangguniang Barangay on November 28, 2015.

**Brgy. Binaliuan Menor** Supplemental Budget No. 2015-001 for CY 2015, involving an Appropriation of P100,000.00 and was approved by the Sangguniang Barangay on December 7, 2015.

**Brgy. Parara Sur** Supplemental Budget No. 2015-001 for CY 2015, involving an Appropriation of P82,586.19 and was approved by the Sangguniang Barangay on November 15, 2015.

**Brgy. 6 (Poblacion)** Supplemental Budget No. 2015-01 for CY 2015, involving an Appropriation of P148,416.95 and was approved by the Sangguniang Barangay on December 2, 2015.

**Brgy. Cansilayan** Supplemental Budget No. 2015-001 for CY 2015, involving an Appropriation of P31,063.59 and was approved by the Sangguniang Barangay on October 11, 2015.

**Brgy. Namocon** Supplemental Budget No. 2015-001 for CY 2015, involving an Appropriation of P81,000.00 and was approved by the Sangguniang Barangay on December 5, 2015.

**Brgy. Binaliuan Mayor** Supplemental Budget No. 2015-002 for CY 2015, involving an Appropriation of P130,000.00 and was approved by the Sangguniang Barangay on December 6, 2015.

**Brgy. Nagba** Supplemental Budget No. 2015-01 for CY 2015, involving an Appropriation of P45,000.00 and was approved by the Sangguniang Barangay on December 7, 2015.

**Brgy. Bangkal** Supplemental Budget No. 2015-01 for CY 2015, involving an Appropriation of P21,115.49 and was approved by the Sangguniang Barangay on November 2, 2015.

**Brgy. 2 (Poblacion)** Supplemental Budget No. 2015-001 for CY 2015, involving an Appropriation of P89,481.55 and was approved by the Sangguniang Barangay on November 21, 2015.

**Brgy. Buenavista** Supplemental Budget No. 2015-01 for CY 2015, involving an Appropriation of P77,213.00 and was approved by the Sangguniang Barangay on December 6, 2015.

**Brgy. Canabuan** Supplemental Budget No. 2015-001 for CY 2015, involving an Appropriation of P119,557.45 and was approved by the Sangguniang Barangay on December 5, 2015.

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
