RESOLUTION AMENDING THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2016 PROGRAM/PROJECT/ACTIVITIES OF 20% IRA FUND FROM FORMULATION OF COMPREHENSIVE DEVELOPMENT PLAN (CDP) TO FORMULATION OF LOCAL SHELTER PLAN (LSP) WITH A TOTAL BUDGET ALLOCATION OF ₱695,055.80 AND APPROVING THE PROJECT/ACTIVITY DESIGN FOR THE FORMULATION OF LOCAL SHELTER PLAN 2016-2024 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, Section 16 of the Local Government Code of 1991 or Republic Act 7160 provides that every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Article IV, Sections 7 and 8 of the Urban Development and Housing Act of 1992 or Republic Act 7279 mandates Local Government Units to conduct an Inventory of Lands and the Identification of Sites for Socialized Housing where informal settlers living in environment-critical areas, danger zones, road-right-of ways, government lands and other marginalized families with no permanent homes to call their own could be relocated or resettled;

WHEREAS, Section 39 of the same Act provides that the local government units shall be charged with the implementation of this Act in their respective localities, in coordination with the Housing and Urban Development Coordinating Council, the national housing agencies, the Presidential Commission for the Urban Poor, the private sector and other non-government organizations;

WHEREAS, these two (2) Acts stipulate the mandate of LGUs to provide for the housing needs for “homeless constituents”, thus “justifying” the need to craft a Local Shelter Plan in order to implement a comprehensive integrated housing and land development program for the municipality’s constituents;

WHEREAS, the Formulation of Comprehensive Development 2016-2021 was already finished and subsequently approved by the Sangguniang Bayan through SB Resolution No. 2015-139, dated December 9, 2015.

WHEREAS, there is a need to adopt the MDC-EXECOM Resolution No. 2016-001 – “Resolution Amending The Annual Investment Program (AIP) CY 2016 Program/Project/Activities Of 20% IRA Fund From Formulation Of Comprehensive Development Plan (CDP) To Formulation Of Local Shelter Plan (LSP) With A Total Budget Allocation Of ₱695,055.80 And Approving The Project/Activity Design For The Formulation Of Local Shelter Plan 2016-2024”;
