RESOLUTION AUTHORIZING MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO TO ENTER INTO A NEW MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE VETERANS BANK (PVB) RELATIVE TO THE BANK'S SALARY LOAN PROGRAM TO QUALIFIED EMPLOYEES OF THE LGU".

WHEREAS, the Municipality has an existing Memorandum of Agreement with the PVB entered into on June 19, 2008, signed by former Mayor James Excelsior Torres;

WHEREAS, sometime in November 2015, a draft MoA was presented by the bank to LGU Tigbauan for signature of Mayor Alquisada and Ms. Elma Tionsay (OIC Treasurer); attached to which are sheets containing new terms and conditions for consideration;

WHEREAS, on November 24, 2015, Hon. Mayor Suzette forwarded to the Sanggunian the subject letter request for the passing of a resolution relative to PBV's proposed new Salary Loan Program for the employees of LGU Tigbauan, and which was subsequently referred to the Committee on Appropriations for its review and recommendation;

WHEREAS, the Committee failed to promptly act on the matter because no copy of the existing MoA can be found in the files of the LGU and the bank's copy was secured only this January 2016. It shall be noted that the stipulations contained in the former MoA is necessary to enable the Committee to comparatively study the terms of the agreement and competently come up with a recommendation on the Mayor's request for a resolution:

WHEREAS, the review of both the existing and proposed MoA is summarized as follows:

a. The existing document or MoA is more detailed, as it contains Sections for Borrower's Eligibility, Documentary Requirements, Terms of Acceptance, Covenants of the Client, Covenants of the Bank and Miscellaneous Provisions which clearly lay down the entire terms and conditions of the agreement in a single document.

The proposed document or MoA does not have said Sections, but merely attaches a tabular presentation of the terms such as loan amount, interest rate, tenor, etc. It was noted, however, that no reference to this attached table is mentioned in the proposed MoA itself.

b. Comparative terms and conditions:

c. Except for provision on Penalties imposed in case of delinquency in monthly loan payment or amortization and on the grace period, most terms and conditions under the proposed Memorandum of Agreement is found favorable to borrower employees.

RESOLVED, to authorize Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada For And In Behalf Of The Municipality Of Tigbauan, Province Of Iloilo To Enter Into A New Memorandum Of Agreement With The Philippine Veterans Bank (PVB) Relative To The Bank's Salary Loan Program To Qualified Employees Of The LGU".
