**Resolution No. 2016- 009**

RESOLUTION APPROVING THE HOLDING OF COCKFIGHTING AT BARANGAYS ALUPIDIAN, BARROC, BINALIUAN MAYOR, BITAS AND ISIAN, THIS MUNICIPALITY.

WHEREAS, the following Barangays had forwarded to this August Body their Resolutions, to wit:

**Brgy. Alupidian Resolution No. 15-2015-** *“Resolution Requesting the Honorable Sangguniang Bayan of Tigbauan, Iloilo to Grant Permit for Holding 1Day Cockfighting Event on January 24, 2016 in Barangay Alupidian, Tigbauan, Iloilo in Connection of the Celebration of Barangay Patronal Fiesta.”*

**Barangay Barroc Resolution No. 001-2016-** *“Resolution Requesting The Honorable Sangguniang Bayan Of Tigbauan, Iloilo To Grant Permit For Holding 2 Days Cockfighting Event On January 27 And 28, 2016 In Barangay Barroc, Tigbauan, Iloilo In Connection Of The Celebration Of Barangay Patronal Fiesta.”*

**Barangay Binaliuan Mayor Resolution No. 01-2016-** *“Resolution Requesting The Honorable Sangguniang Bayan Of Tigbauan, Iloilo To Grant Permit For Holding The Cockfighting Events On January 29-30, 2016 In Barangay Binaliuan Mayor, Tigbauan, Iloilo In Connection Of Its Annual Fiesta Celebration On January 29-30, 2016.”*

**Barangay Bitas Resolution No. 2016-001** *“Resolution Requesting Approval From The Honorable Sangguniang Bayan Of Tigbauan, Iloilo To Hold A 2 Days Cockfighting Event On February 9 & 10, 2016 In Barangay Bitas, Tigbauan, Iloilo.*

**Barangay Isian Resolution No. 01 - 2016,** *“Resolution Requesting The Honorable Sangguniang Bayan of Tigbauan, Iloilo To Grant Permit For Holding 2 Days Cockfighting Event On February 5 & 6, 2016 In Barangay Isian, Tigbauan, Iloilo In Connection Of The Celebration Of Barangay Patronal Fiesta”*

WHEREAS, on December 26, 2013, this August Body passed Municipal Ordinance No. 2013-005, entitled: **“AN ORDINANCE GRANTING A.P. TENDERO SPORTS ARENA-GALLERA DE TIGBAUAN, A FRANCHISE TO ESTABLISH, MAINTAIN AND OPERATE A COCKPIT IN THE MUNICIPALITY OF TIGBAUAN”;**

WHEREAS, on December 27, 2013 said ordinance was forwarded to the Sangguniang Panlalawigan for review and the same was returned and declared as legal and valid;

WHEREAS, Sec. 7.2, Sec. 7.3 & Sec. 7.4 of said ordinance provide:

**Section 7.2.** In the absence of licensed cockpit in the barangay, cockfighting maybe allowed during the celebration of barangay annual fiesta for not more than three (3) days to be held in the place provided for cockfighting; Provided, however, that Sangguniang Bayan resolution and Mayor’s permit shall be secured prior to the scheduled cockfighting. In the event of conflict of schedule of cockfighting between the licensed cockpit and the barangay, the former shall prevail and the barangay cockfight shall be held before or after the scheduled cockfight in the licensed cockpit;

**Section 7.3** Pre-requisites Of Holding Cockfighting In The Barangay. Barangay concerned shall be responsible in processing all the requirements needed in conducting cockfighting in the barangay. Two (2) weeks before the holding of cockfighting, concerned barangay shall pass a resolution addressed to the Sanggunian Bayan and copy furnished the cockpit franchisee for proper action and/or approval. Only upon approval of the cockpit franchisee and the Sangguniang Bayan, the barangay shall process their Mayor’s permit and pay corresponding fees at the Municipal Treasurer’s Office.

**Section 7.4.** Only licensed cockpit personnel shall administer the cockfighting in the franchise cockpit and in every barangay fiesta celebration with the presence of one (1) personnel from the Municipal Treasurer’s Office.”

WHEREAS, this August Body hereby approves the conduct of such activity subject to compliance by the barangays concerned of the said ordinance particularly with regard to the aforementioned provisions;

WHEREAS, non-compliance of the requirements on the part of **Barangays Alupidian, Barroc, Binaliuan Mayor, Bitas and Isian** shall be sufficient cause for the cancellation of this approval and/or legal action;


