**Resolution No. 2016-013**

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY INTERESTED CONCESSIONAIRES FOR THE SEVEN (7) VACANT FISHING SITES OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

**WHEREAS, Municipal Ordinance No. 2014-010**, otherwise known as “AN ORDINANCE ENACTING THE ENVIRONMENT CODE OF THE MUNICIPALITY OF TIGBAUAN”, **Chapter 10, Article J- Section 1D No. 18** thereof provides:

*“18. Time and Place of Auction. The Sangguniang Bayan shall, in a resolution, provide for the holding of the public bidding for the granting of the concessions, lease or contracts, specifying the time, date and venue of such auction, the minimum bids, the amount to be deposited for entitlement to participate, the procedure to be followed by the committee, and the amount of bond as guaranty of good faith and for satisfactory compliance to the terms of the grant or license. Thus, the grant of lease of fishery rights through public auction shall be for a period of one year and in cash basis of 100%. ”;*

**WHEREAS**, pursuant to the aforementioned provision of the Environment Code, the Sanggunian hereby schedules the holding of the public bidding last July 27, 2015, **2:00 o’clock in the afternoon at the SB Session Hall;**

**WHEREAS**, hereunder provided are the different fishing zones in the Municipality of Tigbauan, which were subject for public bidding with the required minimum amount of bid (*as provided for under Chapter 10, Section 1D 21 of the said code*):

WHEREAS, with these nine (9) fishing zones only two (2) fishing zones had been granted to the winning bidders namely Lim-ao Fishing Zone to Mr. Mamerto Tañagras, Jr. of Brgy. Parara Sur, Tigbauan, Iloilo and Odong Quine Fishing Zone to Mr. Romark A. Taleon of Brgy. Buyu-an, Tigbauan, Iloilo;

WHEREAS, **Municipal Ordinance No. 2014-010**, otherwise known as “AN ORDINANCE ENACTING THE ENVIRONMENT CODE OF THE MUNICIPALITY OF TIGBAUAN”, **Chapter 10, Article J- Section 1D No. 9** thereof provides:

*“9. Concessions. Subject to the usual accounting and auditing rules, the Municipal Mayor through the MAO/MFO, may allow identified fishery activities in clearly defined areas of the Municipal Waters through public bidding. The Sangguniang may authorize the Mayor to enter into a negotiated contract. Provided, that negotiations for concessions shall be construed under conditions of utmost transparency and be subject to the review and approval of the Sanggunian, through its Committee on Fisheries”;*

WHEREAS, almost four months after the date of the public bidding for the concession to operate those identified fishing sites, interested persons had expressed their desire to put up “tangkal-tangkal” in some of these areas;

WHEREAS, there is a need to authorize the Municipal Mayor to enter into negotiated contracts with these interested operators;


NOW, THEREFORE, on motion of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, Vice Chairperson, Committee on Agriculture, Aquatic Resources and Cooperatives and duly seconded by Hon. Jose Donel Trasporto, Hon. Renee Librodo-Valencia, Hon. Virgilio Teruel and Hon. Suzette Marie Hilado-Banno,

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Negotiated Contract With Any Interested Concessionaires For The Seven (7) Vacant Fishing Sites Of The Municipality Of Tigbauan, Province Of Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, this municipality and all concerned for their information and/or appropriate action.
