RESOLUTION CONFORMING AND APPROVING THE CY 2016 ANNUAL BUDGET, ANNUAL INVESTMENT PLAN, 20% DEVELOPMENT PLAN AND 5% BDRRMF PLAN OF **BARANGAY BUGASONGAN**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on January 6, 2016, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2016 Annual Budget, 20% Development Plan, and 5% BDRRMF Plan of Barangay Bugasongan, to wit:

Barangay Bugasongan CY 2016 General Annual Budget Involving an Appropriation of P1,017,500.00, 20% Development Fund in the amount of P202,400.00, and 5% BDRRMF in the amount of P50,875.00 Approved by Sangguniang Barangay on October 18, 2015 and Enacted Under Appropriation Ordinance No. 2015-01;

WHEREAS, the Municipal Budget Officer had reviewed the said Barangay Annual Budget, 20% Development Plan, and 5% BDRRMF Plan which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budget, 20% Development Plan, and 5% BDRRMF Plan of the afore-mentioned barangay likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budget of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budget shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Jose Donel Trasporto, *Committee Vice Chairman* (under the sponsorship of HON. RENEE LIBRODO-VALENCIA, *Chairperson, Committee on Appropriations*) and duly seconded by Hon. Virgilio Teruel, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan;

RESOLVED, to conform and approve the CY 2016 Annual Budget, Annual Investment Plan, 20% Development Plan and 5% BDRRMF Plan of Barangay Bugasongan, this municipality,

RESOLVED FURTHER, to furnish copies of this Resolution to the following: Hon.
