RESOLUTION ADOPTING THE LOCAL ANTI-CRIMINALITY ACTION PLAN (LACAP) OF THE MUNICIPALITY OF TIGBAUAN FOR CY 2016

WHEREAS, an urgent letter from the Municipal Mayor dated March 9, 2016 was received by the Office of the Sangguniang Bayan, requesting for the passage of a *“Resolution Ratifying 2015 Local Anti-Criminality Action Plan (LACAP) and Adopting 2016 Local Anti-Criminality Action Plan of the Municipality of Tigbauan”*;

WHEREAS, the Committee on Peace & Order and Public Safety to which this matter was referred to, during a meeting conducted to discuss and review the Programs and the Budgetary requirements of the 2016 Local Anti-Criminality Action Plan, in which each item with their corresponding budget allocation was discussed thoroughly by P/Insp. Hermogenes E. Eulatic wherein the documents were found to be fair, just, legal and in order;

WHEREAS, it was also clarified during the meeting that the activities identified by our local PNP as reflected in the LACAP, represent the activities intended to address the major criminalities within this municipality such as the major problem of illegal drugs, vehicular accidents and crimes/offenses committed by minor offenders;

WHEREAS, the original budget they requested from the office of the Mayor was P450,000, however, due to budgetary constraints the same was reduced to P292,681, a budget which is larger than last year’s budget;

WHEREAS, the program of activities and budgetary allocation presented by P/Insp. Hermogenes Eulatic as reflected in the LACAP are found to be consistent to the prescribed programs of the PNP, and are in line with its vision and mission and likewise consonant with the ideals being pursued by the Municipal government;
