RESOLUTION APPROVING THE GRANT OF STEP INCREMENTS TO ELECTIVE OFFICIALS OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO PURSUANT TO THE CIVIL SERVICE COMMISSION (CSC) AND THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) JOINT CIRCULAR NO. 01, S. 2016 dated JANUARY 27, 2016

WHEREAS, on January 27, 2016, the Civil Service Commission (CSC) and the Department of Budget and Management (DBM) issued Joint Circular No. 1, s. 2016 on the subject Rules and Regulations on the Grant of Step Increments to Elective Officials Based on Length of Service;

WHEREAS, prior to Joint Circular No. 1, s. 2016, the CSC and the DBM has issued Joint Circular No. 1, s. 2012 dated September 3, 2012 on the grant of step increment/s due to meritorious performance and step increment due to length of service, item No. 4 of which elective officials were excluded from coverage thereof;

WHEREAS, Opinion No. 38, s. 2012 by the Department of Justice concluded that elective officials are covered and entitled to the step increment pursuant to R.A. No. 6758 entitled Compensation and Position Classification Act of 1989;

WHEREAS, grant of step increment based on length of service to elective local officials of the Municipality of Tigbauan would eliminate the double standard created by the exclusion of said employees from coverage under aforesaid Joint Circular No. 1, s. 2012, recognize their services and thus, boost the morale of elective officials;

WHEREAS, the grant of step increment to elective officials based on length of service shall strictly comply with the terms and conditions laid down in the CSC-DBM Joint Circular No. 1, s. 2016 particularly items No. 6, No. 8, No. 10.2 and No. 11 thereof;
