RESOLUTION AUTHORIZING THE HONORABLE MAYOR SUZETTE TENEFRANCIA-ALQUISADA TO REQUEST FROM HIS EXCELLENCY BENIGNO SIMEON AQUINO III FUND FOR SOCIAL SERVICES PROGRAM THRU THE PROVISION OF FINANCIAL ASSISTANCE FOR THE CASH FOR WORK, TRANSPORTATION AND FOOD ASSISTANCE TO THE NEEDY, MARGINALIZED AND VULNERABLE DISADVANTAGED INDIVIDUALS AND FAMILIES IN THE MUNICIPALITY OF TIGBAUAN, 1ST CONGRESSIONAL DISTRICT OF THE PROVINCE OF ILOILO IN THE AMOUNT OF NINE MILLION FOUR HUNDRED SEVENTY THREE THOUSAND PESOS (PHP 9,473,000.00)
