RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN MEMORANDA OF AGREEMENT WITH FIFTY TWO (52) PUNONG BARANGAYS OF THE MUNICIPALITY OF TIGBAUAN FOR THE TRANSFER OF 20% DEVELOPMENT FUND FOR THE PROGRAMS AND PROJECTS TO BE IMPLEMENTED BY THE BARANGAYS FOR FISCAL YEAR 2016

WHEREAS, the 2016 Executive Budget of Tigbauan earmarked funds from its 20% IRA Development Fund for various projects intended to address priority concerns of the barangays such as street lights, water system, drainage, concrete pavements, multi-purpose centers and others amounting to a total of at least P2.50 million (schedule attached as Annex A);

WHEREAS, the LGU has encountered difficulty in implementing projects by administration through the Municipal Engineering Office, on which the Commission on Audit has specially called the attention of the concerned officers in its AOM 2016-005 audit findings for the Fiscal Year 2015;

WHEREAS, in order to resolve the issue raised by the auditors, the transfer of funds for and implementation of these projects to the Barangays may be adopted, thereby empowering the Barangay Officials and also decongesting the work load of the Municipal Engineer's office which at present lacks sufficient staff to attend to projects coming from both local and national agencies;

WHEREAS, in order to ensure the effective and efficient implementation of the abovementioned projects by the Barangay Units, a Memorandum of Agreement is necessary which shall lay down the guidelines and expectations particularly on compliance with certain programs and pertinent laws;

NOW, THEREFORE, upon the request of Mayor Suzette Tenefrancia-Alquisada, on motion of HON. RENEE LIBRODO-VALENCIA, Chairperson, Committee on Appropriations and Committee on Infra-structure duly seconded by Hon. Virgilio Teruel, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan;

RESOLVED, to Authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, For and In Behalf Of the Municipality of Tigbauan To Sign Memoranda of Agreement with Fifty Two (52) Punong Barangays of the Municipality of Tigbauan for the Transfer of 20% Development Fund for the Programs and Projects to be Implemented by the Barangays for Fiscal Year 2016
