### Resolution No. 2016-063

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ILOILO PROVINCIAL GOVERNMENT TO AVAIL OF THE SERVICES AND BENEFITS OFFERED BY THE ILOILO PROVINCIAL DEVELOPMENT CENTER FOR WOMEN AND CHILDREN (IPDCWC)

WHEREAS, R.A, 7610, otherwise known as the "Special Protection of Children, Abuse Exploitation and Discrimination Act" stated that it shall be the policy of the state to provide special protection to children from all forms of abuse, neglect, cruelty, exploitation and discrimination and other conditions prejudicial to their development;

WHEREAS, the Iloilo Provincial Development Center for Women and Children (IPDCWC for brevity), a crisis centre under Iloilo Provincial Government (IPG) was established to resolve the cases on Violence against Women and Children (VAWC) and other behavioral patterns problems to serve, assist and protect individuals and families, women, and children in crisis situation in ways that strengthen their coping capacity and encourage personal responsibility, to prevent them from further exposure to calamity, exploitation, abuse, neglect and displacement and to enable them restore their normal functioning towards family reunification and community reintegration;

WHEREAS, the Municipality of Tigbauan is no exception to these kinds of problems, for time and again there are women and children who become victims of abuse, neglect, cruelty, exploitation and discrimination and other conditions;

WHEREAS, the Local Government Unit of Tigbauan has no available funds to establish this kind of shelter for the time being;

WHEREAS, the LGU Tigbauan needs to execute a Memorandum of Agreement (MOA) with the Iloilo Provincial Government (IPG) to avail of the services of its crisis center known as the Iloilo Provincial Development Center for Women and Children (IPDCWC) thereby committing itself to shoulder the Forty Percent (40%) of the total expenses to be incurred by the referred client/victim, as counterpart,

WHEREAS, for and in consideration of the foregoing premises and the mutual covenants herein contained, the PARTIES, do hereby bind themselves and agree to the following:

# 1. Duties and Responsibilities of the Parties:

# 1.1 The Iloilo Provincial Government (IPG): the FIRST PARTY

- 1.1.1 Accept clients being referred to the IPDCWC from the Second Party;
- 1.1.2 Validate and assess required documents submitted by the Second Party; and ensure facilitation of the immediate need of the client;
- 1.1.3 Collect the corresponding amount from the Second Party for the care and maintenance of the referred clients consistent with the Manual of Operation pertaining thereof;
- 1.1.4 Conduct pre-case conferences with the Social Worker assigned and other concerned personnel or individuals; and
- 1.1.5 Assess and observe the referred clients with a minimum of one (1) week and maximum of two (2) weeks depending on his/her behavioral development;
- 1.1.6 Regular conference with the Social Worker of the LGU where the client originated.

# **1.2** The Municipality of Tigbauan, the SECOND PARTY:

- 1.2.1 Submit the letter of intent ahead or along with the referred clients to the IPDCWC;
- 1.2.2 Require the referred clients to complete documents such as but not limited to certificate of live birth, police blotter, medical certificate, referral letter from the Municipal Social Welfare and Development Officer (MSWDO) or any Social Worker of the concerned agency/entity and social case study report;
- 1.2.3 Adhere on other provisions provided in the adopted Manual of Operation in the IPDCWC of this MOA;
- 1.2.4 Pay the corresponding fees for care and maintenance of the referred clients;
- 1.2.5 Require Social Worker concerned to render counseling and monitoring at least once a week to monitor the status of the referred clients;
- 1.2.6 Be responsible to the client or person being referred in the event of termination of confinement/rehabilitation/expulsion/suspension; that includes facilitating/bringing the client to his/her home/custodian, should it be necessary;

NOW, THEREFORE, on motion of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, Chairperson, Committee on Education, Women and Family, Social Services and Senior Citizens, and duly seconded by Hon. Renee Librodo-Valencia, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the Municipality of Tigbauan, to enter into a Memorandum of Agreement with The Iloilo Provincial Government to avail of the services and benefits offered by the Iloilo Provincial Development Center for Women and Children (IPDCWC)
