RESOLUTION CONFORMING AND APPROVING THE CY 2016 ANNUAL BUDGET, ANNUAL INVESTMENT PLAN, 20% DEVELOPMENT PLAN AND 5% BDRRMF PLAN OF **BARANGAY SERMON**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on July 13, 2016, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2016 Annual Budget, 20% Development Plan, and 5% BDRRMF Plan of Barangay Sermon, to wit:

***Barangay Sermon** CY 2016 General Annual Budget Involving an Appropriation of P1,069,887.00, 20% Development Fund in the amount of P213,977.40, and 5% BDRRMF in the amount of P53,869.35 Approved by Sangguniang Barangay on October 5, 2015 and Enacted Under Appropriation Ordinance No. 2015-01;*

WHEREAS, the utilization of the Annual Budget shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;


