RESOLUTION CONFORMING AND APPROVING THE CY 2016 SUPPLEMENTAL BUDGET OF BARANGAY BAGUINGIN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on August 8, 2016 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2016 Supplemental Budget embodying Appropriation Ordinance of Barangay Baguingin, to wit:

Brgy. Baguingin Supplemental Budget No. 2016-001 for CY 2016, involving an Appropriation of P48,505.00 and was approved by the Sangguniang Barangay on August 8, 2016.

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
