RESOLUTION CONFORMING AND ADOPTING RESOLUTION NO. 2016-02 OF THE MUNICIPAL DEVELOPMENT COUNCIL (MDC), RESOLUTION CONFORMING AND APPROVING THE RE-ALIGNMENT OF VARIOUS BARANGAY PROJECTS CHARGED AGAINST THE 20% IRA FUND OF APPROVED CY 2016 ANNUAL INVESTMENT PLAN (AIP) OF THE MUNICIPALITY OF TIGBAUAN.

WHEREAS, the Municipal Development Council (MDC) passed Resolution No. 2015-001, approving the Annual Investment Plan (AIP), 20% Internal Revenue Allotment (IRA) Fund, General Expenditures Fund (P.S., M.O.O.E., C.O.), GAD Fund, MDRRM Fund and Other Sources for C.Y. 2016 of the Municipality of Tigbauan, Province of Iloilo;

WHEREAS, the 20% Development Fund in the amount of P22,675,055.80 is appropriated as embodied in the CY 2016 AIP which shall be utilized for programs, projects and activities incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the MDC's participation is necessary for the conforming and approving in the re-alignment of various barangay projects charged against the 20% IRA Fund of approved CY 2016 Annual Investment Plan (AIP) of this municipality;

- Barangay 3- Development of Barangay Day Care Center to Municipal Rural Development Program (MP Pavement)
- Barangay 4- Municipal Rural Development Program to Barangay Drainage Development Program
- Barangay Namocan-Development of Barangay Calamity Related Program (Generator) to Development of Barangay Multi-Purpose Center
- Barangay Napnapan Sur-Development of Barangay Multi-Purpose Center to Barangay Drainage Development Program
