RESOLUTION GRANTING OMNIBUS AUTHORITY TO HONORABLE MAYOR SUZETTE T. ALQUISADA OF THIS MUNICIPALITY TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT BETWEEN THE ILOILO PROVINCIAL GOVERNMENT AND MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO FOR THE TRANSFER OF FUNDS/GRANT OF FINANCIAL ASSISTANCE.

WHEREAS, the Iloilo Provincial Government (IPG) has appropriated funds under its 2016 Annual Budget for the implementation of infrastructure, socio-cultural projects of different municipalities in the Province of Iloilo;

WHEREAS, the Local Government Unit (LGU) of Tigbauan has requested funds/financial assistance for implementation of various projects from IPG;

WHEREAS, there is a need for execution of Memorandum of Agreement in order to release/transfer the funds to the Municipality of Tigbauan;

WHEREAS, Section 444 (a), (b), (vi) of the Local Government Code provides among others, to wit:

**SEC. 444. The Chief Executive: Powers, Duties, Functions and Compensation.** - (a) *The Municipal Mayor, as the chief executive of the municipal government, shall exercise such powers and perform such duties and functions as provided by this Code and other laws.*

(b) *For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

X X X

(vi) *Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;*

WHEREAS, through this undertaking, the fast and efficient delivery of services will be ensured and will definitely inure to the benefit and general welfare of the people of Tigbauan;

WHEREAS, to assure full transparency and accountability, the Local Chief Executive shall periodically update the local Sanggunian of the projects and programs that LGU Tigbauan undertakes in partnership with the IPG;


