RESOLUTION TRANSFERRING THE CELEBRATION OF ADLAW SANG TIGBAUAN FOR THE YEAR 2016, FROM THE LAST FRIDAY OF OCTOBER TO THE SECOND FRIDAY OF OCTOBER TO GIVE AMPLE TIME FOR THE MUNICIPALITY TO PREPARE FOR THE FIRST CONGRESSIONAL DISTRICT SPORTS ASSOCIATION (FCDSA) MEET 2016.

WHEREAS, the Code of General Ordinances of the Municipality of Tigbauan, Province of Iloilo amended Municipal Ordinance No. 2000-002, *An Ordinance Declaring the Third Friday of October each year as "Adlaw Sang Tigbauan" to Fourth Friday of October* to coincide with the semestral vacation of the schools;

WHEREAS, Adlaw Sang Tigbauan is a local holiday giving significance to the history and culture wherein said date is believed to be the foundation day of civilization and Christianity in this part of the country;

WHEREAS, this day also marks the start of the harvest season, thus an opportune time of "Thanks-giving" by the people of this municipality;

WHEREAS, for several years now, it has become a week-long celebration wherein the youths are given an opportunity to handle the affairs of the local government thru the Boy and Girl Officials; the Municipal Mayor as the Local Chief Executive renders a report to the people of Tigbauan thru the State of the Municipality address (SOMA); and the Stylized Folk Dance Competition which is the highlight of the celebration;

WHEREAS, this year's FCDSA Meet however, is scheduled on the first week of November, thus the appeal of different school administrators that the students be allowed to go on training and practice on the fourth week of October;
