RESOLUTION AUTHORIZING MAYOR SUZETTE TENEFANCIA-ALQUISADA TO REQUEST FUND FROM PRESIDENT RODRIGO ROA DUTERTE FOR SOCIAL SERVICES PROGRAM THRU THE PROVISION OF FINANCIAL ASSISTANCE FOR THE MEDICAL, BURIAL, TRANSPORTATION, CASH FOR WORK, AND FOOD ASSISTANCE TO THE NEEDY, MARGINALIZED AND VULNERABLE DISADVANTAGED INDIVIDUALS AND FAMILIES IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, IN THE AMOUNT OF EIGHT MILLION ONE HUNDRED TWENTY THOUSAND PESOS (PHP 8,120,000.00) FOR ESTIMATED BENEFICIARIES OF 8,120 FAMILIES/HOUSEHOLDS.
