RESOLUTION CONFORMING AND ADOPTING RESOLUTION NO. 2016-04 OF THE MUNICIPAL DEVELOPMENT COUNCIL (MDC), RESOLUTION CONFORMING AND APPROVING THE RE-PROGRAMMING OF THE 5% GENDER AND DEVELOPMENT PPAS FROM IDENTIFIED CAPACITY DEVELOPMENT PROGRAM TO HEALTH DEVELOPMENT PROGRAM FOR MALE AND FEMALE EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00).

WHEREAS, the annual budget for FY 2016 of the Municipality of Tigbauan, Province of Iloilo amounting to P125,882,100.00 was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2015-005, approved on November 11, 2015;

WHEREAS, the 5% GAD Fund of the Municipality of Tigbauan in the amount of P5,911,763.95 shall be disbursed and utilized strictly pursuant to provisions of RA 7192 (Women in Development and Nation Building Act), other related laws, their implementing rules and regulations and the DBM/NEDA/NCRFW Joint Circular No. 2004-1;

WHEREAS, out of this 5% GAD Fund, P350,000.00 was allocated for the Capacity Development Program of the Municipal Officials and Employees of the Local Government Unit of Tigbauan and a portion of it amounting to P100,000.00 shall be re-programmed to Health Development Program for male and female employees that will undergo medical laboratory examinations since there was no funds included in the 2016 Annual Budget intended for this purpose;
