RESOLUTION CONFORMING AND APPROVING THE CY 2016 SUPPLEMENTAL BUDGET OF BARANGAYS SUPA AND NAPNAPAN NORTE, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on August 30, 2016 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2016 Supplemental Budgets embodying Appropriation Ordinances of the following barangays:
