RESOLUTION GIVING DUE RECOGNITION TO DR. ROEL T. JARINA, FORMER VICE MAYOR, FOR HIS EXEMPLARY CONTRIBUTIONS AND DEDICATED SERVICE TO THE LOCAL GOVERNMENT UNIT OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, Dr. Roel "Biboy" Jarina had served the people of the Municipality of Tigbauan as Member of the Sangguniang Bayan from 2004 to 2007, and because of his exemplary performance he became the undefeated Vice Mayor of this Municipality for three consecutive elections of 2007, 2010 and 2013;

WHEREAS, during his terms of office as Member of the Municipal Council and as Municipal Vice Mayor, Dr. Roel T. Jarina had served his constituents with dedication and commitment. He rendered service as Chairman and member of various committees in the Municipal Council, the latest of which was as Chairman of the Committee on Health & Sanitation and Committee on Market & Slaughterhouse;

WHEREAS, Dr. Roel T. Jarina had pushed several projects for the betterment of his constituents and as Chairman of the Committee on Market & Slaughterhouse, one of the notable projects which was accomplished was the construction of *Phase 1* and *Phase 2* of the Tigbauan Public Market and the two-storey vegetables, fish and meat sections;

WHEREAS, his valuable contributions in local legislation include among others, the following Municipal Ordinances:

1. **Mun. Ord. No. 2014-020** – "AN ORDINANCE PROVIDING FOR THE DISPOSITION AND ALLOCATION OF THE PER FAMILY PAYMENT RATE (PFPR) PROCEEDS FROM THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) FOR UNIVERSAL HEALTH CARE PRIMARY CARE BENEFIT I (PCBP) PACKAGE IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO."
2. **Mun. Ord. No. 2014-019** – "AN ORDINANCE PROVIDING FOR THE DISPOSITION AND THE UTILIZATION OF TB-DOTS PACKAGE FUND OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO."
3. **Mun. Ord. No. 2014-018** – "AN ORDINANCE REGULATING BACKYARD SWINE RAISING IN THE MUNICIPALITY OF TIGBAUAN AND PROVIDING PENALTIES IN VIOLATION THEREOF."

4. **Mun. Ord. No. 2014-005** – “AN ORDINANCE AMENDING SECTION 8 OF MUNICIPAL ORDINANCE NO. 2008-011 – IMPOSING FEE FOR THE SERVICE MAINTENANCE OF THE MUNICIPAL BIRTHING CLINIC OF THE RURAL HEALTH UNIT, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO AND PROVIDING PENALTIES IN VIOLATION THEREOF.”
5. **Mun. Ord. No. 2013-002** – “AN ORDINANCE FORMULATING THE BLOOD TYPING REGISTRY PROGRAM OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.”
6. **Mun. Ord. No. 2008-006** – “AN ORDINANCE ADOPTING AND PROMULGATING THE RULES OF ADMINISTRATIVE CASES FILED AGAINST ANY ELECTIVE BARANGAY OFFICIALS.”
7. **Mun. Ord. No. 2007-001** – “AN ORDINANCE IMPOSING/CHARGING LABORATORY FEES FOR CBC PLATELET, HEMOGLOBIN/HEMATOCRIT, URINALYSIS, STOOL EXAMINATION AND RBS FEES FOR THE MAINTENANCE OF LABORATORY SERVICES IN THE RURAL HEALTH UNIT, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.”;

WHEREAS, as Municipal Vice Mayor and Presiding Officer of the Municipal Council, Dr. Roel T. Jarina had exerted efforts to improve local legislation for which he was instrumental for the passage of the 3 - important codes of this municipality, namely: the CODE OF GENERAL ORDINANCES, the INVESTMENT AND INCENTIVE CODE and the ENVIRONMENT CODE OF THE MUNICIPALITY OF TIGBAUAN;

WHEREAS, Dr. Roel T. Jarina is best remembered as the *Prime-Mover of the Paperless Session* of the Sangguniang Bayan of Tigbauan that had resulted to efficient and effective local legislation and public service. Likewise, he was also known as the *Father of Stylized Folk Dance* in the Municipality of Tigbauan;

WHEREAS, on March 23, 2016, by reason of his unwavering commitment to public service, selfless dedication to work and laudable record in his medical profession and practice, Dr. Roel T. Jarina was appointed Chief of Hospital of the Western Visayas Sanitarium at Sta. Barbara, Iloilo;


