5. **Mun. Ord. No. 2010-005** - "AN ORDINANCE DECLARING SEPTEMBER 2 OF EVERY YEAR (THE FIRST AMBUSH IN SOUTHERN PANAY CELEBRATION IN BRGY. NAMOCON) A NON-WORKING HOLIDAY IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO."

6. **Mun. Ord. No. 2013-005** – “AN ORDINANCE GRANTING A.P. TENDERO SPORTS ARENA – GALLERA DE TIGBAUAN, A FRANCHISE TO ESTABLISH, MAINTAIN AND OPERATE A COCKPIT IN THE MUNICIPALITY OF TIGBAUAN.”

WHEREAS, the significant amendments he had introduced to the ordinance granting franchise to the A.P. Tendido Sports Arena to operate as a cockpit in the Municipality of Tigbauan have greatly benefited the majority of the barangays especially during fiestas and other special occasions;
