RESOLUTION APPROVING THE ESTABLISHMENT OF A BIRTHING FACILITY IN BARANGAY BUYUAN, BARANGAY HEALTH STATION OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO AND WILL BE NAMED BUYUAN HEALTH STATION AND BIRTHING CENTER

WHEREAS, Barangay Buyuan has an existing Barangay Health Station (BHS) located at Buyuan, Tigbauan, Iloilo that serves as the catchment area for Barangays Buyuan, Supa and Cansilayan;

WHEREAS, the LGU-Tigbauan, with the assistance of the Department of Health through its Health Facility Enhancement Program (HFEP) projects and with the assistance also from European Union Countries is working out for the upgrading of Buyuan BHS as Birthing Facility in order to improve its preventive health care services under the Philippine Health Agenda, *"All For Health Towards Health For All"*;

WHEREAS, consistent with the mandate of LGUs to promote the general welfare of the people, the proposed upgrading of the Buyuan BHS and the establishment of a Birthing Facility shall ensure that all constituents of Barangay Buyuan and its neighboring barangays, especially the poor and marginalized groups, have equitable access to affordable health care;

WHEREAS, to achieve the standards and targets set for a comprehensive health care system and efficient provision of health services by the Local Government Unit of Tigbauan, the establishment of a Birthing Facility in the Barangay Health Station under the name BUYUAN HEALTH STATION AND BIRTHING CENTER located at Barangay Buyuan, Tigbauan, Iloilo is considered appropriate and desirable;


