RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENROLL IN THE LANDBANK OF THE PHILIPPINES (LBP'S) INTERNET PAYMENT FACILITY KNOWN AS "wePayAccess".

WHEREAS, the Honorable Mayor, in a letter dated September 21, 2016 forwarded to this August Body, an urgent request for the passage of a "Resolution Authorizing The Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan, to Enroll in the Landbank of the Philippines (LBP's) Internet Payment Facility Known as "wePayAccess";

WHEREAS, pursuant to the said urgent request, this Sanggunian hereby authorizes the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the Municipality of Tigbauan, to do the following:

1. Subscribe to the Land Bank of the Philippines (LBP's) internet payment facility known as "wePayAccess"; and
2. Designate Ms. Elma G. Tionsay, OIC, Office of the Municipal Treasurer and Mrs. Salvacion T. Trayfalgar, as authorized signatories to enroll (*aside from the Municipal Mayor, Atty. Suzette T. Alquisada*) and designate Mrs. Salvacion T. Trayfalgar, OIC, Office of the Municipal Accountant and Mrs. Amalia T. Sayson, Administrative Aide I as authorized users in the LANDBANK wePayAccess.

NOW, THEREFORE, on motion of HON. DENNIS T. VALENCIA, Chairman, Committee on Appropriations, Budget, Finance, Accounts and Ways & Means and duly seconded by Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, and Hon. Jerry T. Tuares,

RESOLVED, as it is hereby resolved, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan, to:

1. Execute/sign all documents necessary to subscribe to LBP's "wePayAccess";
2. Designate/authorize the following personnel: *Mrs. Salvacion T. Trayfalgar, OIC, Office of the Municipal Accountant and Mrs. Amalia T. Sayson, Administrative Aide I* to act as "makers", or *Ms. Elma G. Tionsay, OIC, Office of the Municipal Treasurer and Mrs. Salvacion T. Trayfalgar, OIC, Office of the Municipal Accountant (aside from the Municipal Mayor, Atty. Suzette T. Alquisada)* as "authorizers", for the company's access to LBP's "wePayAccess" Internet payment facility; and
3. Amend/add/delete enrolled deposit account/s as source and/or destination account/s access rights to the "wePayAccess" modules, authorization rules and/or any information on the original and succeeding enrollments.

And that the same is hereby confirmed and ratified;

THAT, this is an addendum to the signatories of the submitted resolution for account opening;

RESOLVED FINALLY, to furnish copies of this resolution to all concerned for their information and appropriate action.
