**Resolution No. 2016-124**

RESOLUTION CONFORMING AND APPROVING THE CY 2016 SUPPLEMENTAL BUDGET OF BARANGAY 6 (POBLACION), THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on October 19, 2016 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2016 Supplemental Budget embodying Appropriation Ordinance of the following barangay:

**Brgy. 6 (Poblacion)** Supplemental Budget No. 2016-002 for CY 2016, involving an Appropriation of P500,000.00 and was approved by the Sangguniang Barangay on October 5, 2016.
